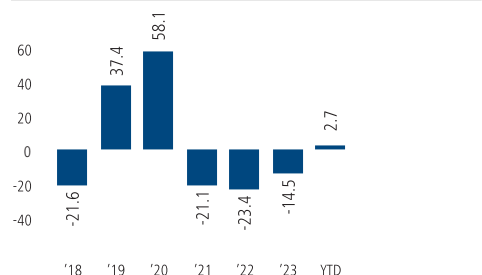

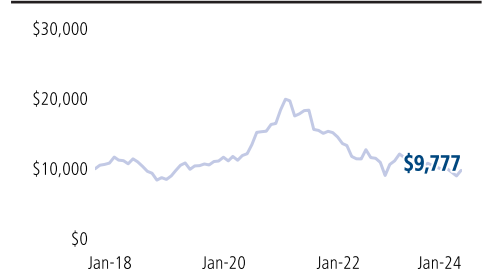

It is based on the concept of the integrated MSCI China equity universe with China A-shares included.
