## Management Discussion of Fund Performance

June 5, 2023
This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the year ended March 31, 2023 (the "period"). If the Fund was established during the period, "period" represents the period since inception.
In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

## Investment Objective and Strategies

The Fund seeks income and capital growth while trying to preserve capital by investing mainly in Canadian government fixed income securities and high-quality, or investment grade, corporate fixed income securities and asset-backed securities. The Fund may hold up to $30 \%$ of its assets in foreign investments.

## Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.
The Fund is suitable for short- to medium-term investors looking for a Canadian fixed income fund to hold as part of their portfolio, who can handle the volatility of bond markets and who have a low tolerance for risk.

## Results of Operations

## Investment Performance

The performance of all series in the current and previous periods is shown in the Past Performance section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the Fund Formation and Series Information section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.
During the period, the Fund's Series SC securities returned $-3.0 \%$, and Series LB securities returned $-3.1 \%$ (after deducting fees and expenses paid by the series). This compares with the FTSE Canada Universe Bond Index return of $-2.0 \%$. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.
In response to persistently high inflation, the Bank of Canada raised its policy rate by 400 basis points over the period, to $4.50 \%$ from $0.50 \%$. Consequently, Government of Canada bond yields increased. The yield increase was more pronounced among shorter-term government bonds, which tend to be more sensitive to central bank policy moves. Higher rates in the government bond market also led Canadian corporate bond yields to increase significantly.
The Fund underperformed the index, with security selection in corporate bonds detracting from performance. Conversely, the Fund's underweight exposure to federal and provincial bonds contributed to performance.
Hedging of foreign currency exposure detracted from performance as a result of the overall appreciation of the hedged currencies relative to the Canadian dollar.

The Fund held government bond futures to manage duration (sensitivity to interest rates), which contributed to performance.
Over the period, the portfolio management team increased the Fund's exposure to Canadian federal bonds because of the Canadian economy's higher sensitivity to interest rates, while the Fund's exposure to U.S. Treasuries was decreased.

## Net Assets

The Fund's net assets decreased by $8.0 \%$ during the period to $\$ 1.5$ billion. This change was composed primarily of $\$ 34.1$ million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of $\$ 96.2$ million due to net securityholder activity (including sales, redemptions and cash distributions).

## Fees and Expenses

The management expense ratio ("MER") for each series during the year ended March 31, 2023, was generally similar to the MER for the year ended March 31, 2022. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MER for Series $D$ decreased due to a decrease in the management fee rate effective April 4, 2022, as noted in the Fund Formation and Series Information section of the report. The MERs for all series are presented in the Financial Highlights section of this report.

## Recent Developments

The portfolio management team expects volatility and uncertainty in fixed income markets to persist for the rest of 2023. By the end of the period, inflation in Canada and the United States was easing but remained elevated, and the Bank of Canada had paused its policy rate increases. The team expects central banks to continue to assess the impact of interest rates on inflation and economic growth before setting future policy. In response to the magnitude of rate increases over the period, the Fund's Canadian duration was kept close to neutral.
Effective March 31, 2023, KPMG LLP was appointed as the auditor of the Fund.

## Related Party Transactions

## Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under Fund Formation and Series Information in this report and as more fully described in the Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also Management Fees.

## Other Related Party Transactions

Investment funds managed by Mackenzie and its affiliates may invest in the Fund. All these investments are made on a prospectus-exempt basis in accordance with the investment objectives of those funds. At March 31, 2023, funds managed by Mackenzie owned $44.4 \%$ of the Fund's NAV, funds managed by I.G. Investment Management, Ltd. owned $18.8 \%$ of the Fund's NAV, and funds managed by The Canada Life Assurance Company and Canada Life Investment Management Ltd. owned $19.0 \%$ of the Fund's NAV. All related party transactions are based on the NAV per security on each transaction day. As a result of these investments, the Fund may be subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions.
At March 31, 2023, Mackenzie had an investment of $\$ 0.02$ million in the Fund (less than $0.1 \%$ of the Fund's NAV).

During the period, the Fund received $\$ 0.2$ million in income distributions from investments in exchange-traded funds ("ETFs") managed by Mackenzie to offset fees paid within those ETFs. There is no assurance that these distributions will continue in the future.

The Manager relied on an approval provided by the Mackenzie Funds' Independent Review Committee to appoint KPMG LLP as the auditor of the Fund, effective March 31, 2023.

## Past Performance

The Fund's past performance information is presented in the following charts and table. It assumes all distributions made by the Fund in the periods presented are reinvested in additional securities of the relevant series of the Fund. The charts and table do not take into account sales, redemption, distribution or optional charges, or income taxes payable by any investor that would have reduced returns. The past performance of the Fund is not necessarily an indication of how it will perform in the future.

## Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. The Manager also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.
LBC Financial Services Inc. ("LBC") is the principal distributor for the LBC series securities of the Fund (as listed under Fund Formation and Series Information) and receives a portion of the management fees that the Fund pays to the Manager. Under this arrangement, LBC was entitled to approximately $25 \%$ of the total management fees that the Manager received from the LBC series of all Mackenzie funds during the period. The Manager is responsible for paying all distribution-related payments to LBC-authorized dealers whose clients invest in the LBC series of the Fund.
The following dealers affiliated with the Manager may be entitled to distributionrelated payments from the Manager on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.
The Manager used approximately $42 \%$ of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distributionrelated payments for the Fund represented on average $35 \%$ of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

## Fund Formation and Series Information

The Fund may have undergone a number of changes, such as a reorganization or a change in manager, mandate or name. A history of the major changes affecting the Fund in the last 10 years can be found in the Fund's Simplified Prospectus.

The sales charge under the sales charge purchase option is negotiated by the investor with their dealer. Securities purchased before June 1, 2022, under the redemption charge purchase option, low-load 3 purchase option and low-load 2 purchase option (collectively the "deferred sales charge purchase options") may continue to be held in investor accounts.
